This document shall amend Contract **RFB.Informal.Abatement 12** for **Asbestos Abatement Services** (“Agreement”) by and between Vistabution, LLC (the “Vendor”) and the State of North Carolina, Department of Public Safety, Office of Recovery and Resiliency (hereinafter referred to individually as “State” or “NCORR”) executed on May 19, 2023. Except as expressly provided in this Amendment, all terms and conditions of the original Agreement shall remain in force and shall apply to this Amendment.
