PROGRAM BACKGROUND AND OVERVIEW

BACK@HOME INITIATIVE

Back@Home North Carolina is a collaborative rehousing initiative.

To stabilize in housing, households need adequate income, affordable housing, and appropriate support and services.

Back@Home addresses these needs through a combination of financial assistance and housing stabilization services, enabling households to obtain and maintain housing.

September 2018 – June 2022

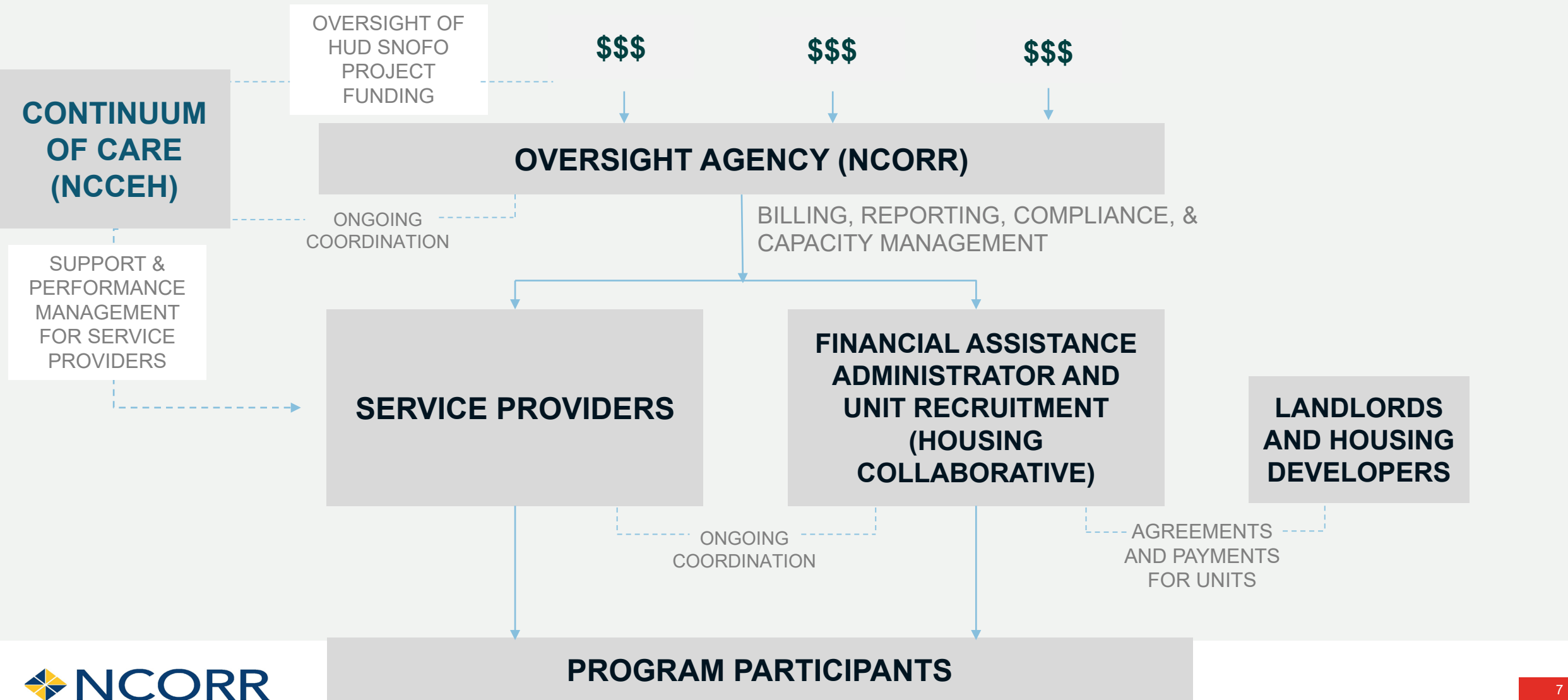
- Back@Home-CV

Target Launch Date: October 1, 2023

PROGRAM MODEL



BUILDING ON LESSONS LEARNED

Back@Home-BoS will:

- Centralize grant administration, reporting and Financial Assistance
- Provide a monthly service provider payment
- Use a Rehousing Support Team model
- Braid together multiple funding sources at state level & leverage other housing resources

REHOUSING SUPPORT TEAM MODEL

- Providing support in teams of two or more to clients
- Approximate ratio of 1:25 case managers: clients
- Quality review and performance management support from the program will be provided

PROGRAM GOALS AND OBJECTIVES

- By Fall/Winter 2026, serve up to 2600 households through combination of housing stabilization, financial assistance, and connection to other resources.
- Provide coverage in all 79 counties of the NC Balance of State Continuum of Care.
- Focus on rural, unsheltered individuals with severe service needs.

AWARD INFORMATION

- Total expected award from HUD: **\$21,884,985**
- Service Provider Payment Structure: **\$400.26 per household per month**
 - Anticipated average contract amount for 3-year period: \$720,468
(50 clients/month)
 - Total number of service provider contracts depends on geographic coverage
- Other sources of funding for the program may become available in the future

APPLICANT ELIGIBILITY

- Nonprofit organizations subject to 26 U.S.C. 501(c)(3) of the tax code (26 U.S.C. 501(c)(3))
- Local government agencies
- Public Housing Authorities
- Native American tribal organizations



THRESHOLD REQUIREMENTS

- Financial management policy compliance
- Must be an eligible entity
 - Nonprofit agencies need to be established for at least 3 years
